



NEW NBEA BRONZE COMPETITION FUNDING – 2017

The New Brunswick Equestrian Association is pleased to announce a new program that provides financial support to sanctioned Bronze competitions in New Brunswick. Funding is available for 25% of the judge's fee to registered and sanctioned Bronze competitions. Judges must be Equine Canada certified judges in the discipline in which they are judging or Guest Carded by EC. General Performance Competitions may use Provincially Approved GP Judges who are residents of New Brunswick and who are gaining experience with the intention of applying for EC status. Stewards will be hired and paid 100% of their day fee by the NBEA to work with new competition organizers before and during their competition. Bronze competitions that are not new and who hire a Steward to work at their competition will receive 25% of the Steward's day fee. Stewards must hold the appropriate EC stewarding card.

In order to receive financial funding, Bronze competitions must submit their competition application form to Equestrian Canada and register with the NBEA before **April 14, 2017**. A signed funding application form, along with a copy of the judge's invoice, must be submitted to the NBEA within 10 days of **each** competition.
