### **Statement of Principles**

Equestrian Canada (EC), the national equestrian federation of Canada, supports adherence to the humane treatment of horses in all activities under its jurisdiction.

EC is committed to:

- upholding the welfare of all horses, regardless of value, as a primary consideration in all activities;
- requiring that horses be treated with kindness, respect and compassion, and that they never be subjected to mistreatment;
- ensuring that owners, trainers and competitors, or their agents use responsible care in the handling, treatment and transportation of their own horses as well as horses placed in their care for any purpose;
- providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure;
- providing current information on Code of Practice for the Care and Handling of Equines and other equine health and welfare initiatives ;
- continuing to support scientific studies on equine health and welfare;
- requiring owners, trainers and competitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competition; and
- reviewing, revising and developing competition rules and regulations that protect the welfare of the horse.

The Standard by which conduct or treatment will be measured is that which a person, informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive, nor inhumane.

## GENERAL RULES

If sending entry electronically ONLY SCANNED COPIES of entry forms will be accepted, NO PICTURES of entry forms.
2. Show Office opens at 7:30 am and will remain open to accept post entries during the show. **Post entries must be received at least 3 classes before the class is to start and payment is to be received at that time.**
3. **Limited stabling for out of town exhibitors only.** Please contact the show secretary for those interested. \$30.00 per stall.
4. Show Committee Members are: Debbie Thomas, Melanie Charette and Barb Litalien.
5. Other than as specified in Article A805.2, a competition may reserve the right to refuse an entry providing the reason for refusal is clearly stated in the prize list (see Article A805.4) The show committee has the right to refuse any entry that is not in good standing with NBEA, Equestrian Canada or competition venue.
6. **This EC-sanctioned competition and all its competitors shall be governed by the current rules of EC.** “Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book.” **General Regulations and Rule Book for Hunter, Jumper, Equitation and Hack may be read on EC website. Rulebooks may be purchased from the NBEA.**
7. Per Article A801, every entry at an EC sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition.
8. Each horse/rider combination must submit separate entries. **All entries must be complete and signed before numbers will be issued.**
9. Entry fees are \$10.00 per class, \$20.00 per Jumper Division and \$25.00 Hunter Divisions entered. **Payment must be received with all entries.**
10. All cheques are to be made payable to: Capital Zone 3 Horse Show (no post-dated cheques). Email money transfers may be sent to [melfin1972@gmail.com](mailto:melfin1972@gmail.com) (password: zoneshow)
11. Post entries are permitted the day of the show and must be received at least 3 classes before the class is to start.
12. Competitors are allowed to enter only **two** Jumper Divisions or Over Fences Hunter Divisions.

**Examples:** Jumper: 0.75m (2'6)/0.85m (2'9) or 0.85m (2'9)/0.90m (3'0)  
Hunter: Intro /Beginner or Beginner/ Low

**Over Fences Jumper Divisions \$20.00 per Division (Open to all)**

0.7m (2'3") Welcome & 0.7m Speed

**\*Jump offs will immediately follow each division**

13. Jumper classes are a timed event. Riders are permitted to walk the course.
14. Eliminations - for falls off horse, rider or both in class; second refusal or exceeding the time limit. \*Riders may jump one single obstacle after elimination providing it is part of the course and it is not due to a fall. (For more see FEI Article 241)

**Over Fences Hunter Divisions \$25.00 per Division (Open to all)**

(Miscellaneous Class not rated for EC awards)  
Cross Rail #1, #2 & Cross Rail Hunter Under Saddle  
Intro Hunter #1, #2 & Intro Hunter Under Saddle  
Beginner Hunter #1, #2 & Beginner Hunter Under Saddle  
Low Hunter #1, #2 & Low Hunter Under Saddle

15. Riders entering the Cross Rail Division are not permitted to enter any other Over Fences Hunter Division.
16. Hors concours is not permitted in Hunter classes (G201) and in Jumper Classes (G501). Hors Concours entries may be accepted at the competition committee's discretion but are subject to the same scoring rules as a regular entry with respect to falls, elimination etc. Such entries are not judged and are not eligible for the jump off. A horse or pony that has competed Hors Concours is not allowed to compete subsequently in the same ring on the same day.
17. Ribbons presented from 1<sup>st</sup> to 6<sup>th</sup> place
18. Judges decision is final.
19. **Entries must be received by July 23, 2018. Late entries will be subject to a \$35.00 late fee.**
20. **HEADGEAR** At all EC-sanctioned competitions, anyone mounted on a horse on the competition grounds, including foreign competitors, must wear approved helmets (see Glossary in General Regulations, Book A), with safety harness correctly fastened, at all times. Juniors showing any horse in a jog for soundness must wear approved protective headwear with the attached safety harness fastened. **G102**
21. ***Any horse entered in any class at this competition may be selected for equine medication control testing while at the event location.***
22. Non-showing horses: All horses brought on the property during the competition must have a signed entry blank and owners must have a current NBEA membership. Anyone riding non competing horses which have been brought on to the show grounds must wear a number issued by the office. Non-showing horses must meet coggins and vaccination requirements.
23. **All entries must attach a copy of the following: NO EXCEPTIONS. Only scanned copies of paperwork will be allowed with entries sent in via email. Pictures of paperwork WILL NOT be accepted.**
  - a. **Proof of current year vaccinations & COGGINS within 1 year of the show date.** \*mandatory vaccinations are tetanus, flu, rabies, rhino & strangles
  - b. **2018 EC Bronze Sport License (or higher)** Bronze EC memberships may be purchased from EC at [www.equestrian.ca](http://www.equestrian.ca) (*Lead line class is exempted from EC Sport License requirements.*)

- c. **2018 NBEA Membership** -All riders including those schooling horses on the competition grounds must be NBEA members.
24. Cross Entries where permitted in the rules are permitted.
  25. Protests must be made in writing and addressed to the secretary of the competition at which the matter under consideration occurs, must be signed and must be accompanied by a deposit of \$100 cash within 48 hours of the competition. See conditions for complaints and protest of rule book Section A General Regulations.
  26. Competitors in this competition are considered Novice if they are in their 1<sup>st</sup> or 2<sup>nd</sup> year showing at any competitions. (Miscellaneous Class not rated for EC awards)
  27. Horses in this competition are considered Green Horses if they are in their 1<sup>st</sup> or 2<sup>nd</sup> year of showing at any competitions. (Miscellaneous Class not rated for EC awards)
  28. At this competition, manageable stallions may only be ridden by seniors competitors. Decisions as to the manageability of stallions are at the discretion of the judge or steward. Unmanageable stallions must be excused from the ring and/or warm-up ring ring numbers must be worn and visible at all times in the schooling and exercise areas as well as in the competition ring.
  29. The show will forfeit 75% of the entry fee less the fees for classes completed if the horse entered is withdrawn due to unsoundness or illness provided a veterinarian's certificate is produced, dated not later than the closing day of the show and received within 10 days of the show date.
  30. Any actions towards a horse deemed abusive or excessive by a judge, steward or show committee members by an exhibitor or anyone anywhere on show grounds may be given an official warning or may be disqualified from the competition. Article A517
  31. The Show Committee, its officials, volunteers or Geary Hill Stables does not assume responsibility for accidents or illness to horses, riders, spectators or any other persons in attendance.
  32. **Classes with less than 3 entries may be combined or cancelled at the discretion of the show committee.**
  33. Novice Rider and Green Horse (miscellaneous classes) are **walk/trot only** classes. Novice Riders may enter and compete in classes for novice riders only. Green horses may enter and compete in classes for green horse only.  
***Riders under 12 years of age who wish to enter walk/trot classes may only compete in Walk/Trot classes.***
  34. EC rule book is available on the Equestrian Canada website at: [www.equinecanada.ca](http://www.equinecanada.ca) and a hard copy will be on site the day of the horse show. The competition will be conducted under the rules of EC Hunter, Jumper, Equitation and Hack, Section G. Miscellaneous class descriptions are provided in the Prize List.
  35. Each horse/rider combination is allowed to enter a maximum of **15** under saddle classes.
  36. No fee for substitution of a horse (A603).
  37. Competitors may leave the grounds after their last class and their number has been returned.
  38. Lunging will not be permitted in warm-up area if there are riders warming up. Lunging can be permitted before 7:30 am. Warm up open to riders after 7:30 am. **No more than two people may lunge at one time.**
  39. **NO SMOKING** anywhere on the competition grounds.
  40. Dogs must be on a leash at all times while on the show grounds.
  41. Every class offered herein is covered by the rules and specifications of the current rules of Equestrian Canada and will be held and judged in accordance with the Equestrian Canada Rule Book. Any incident

requiring a ruling which cannot be referenced to the EC Rule Book, will be rendered by the Show Committee.

42. **Ages for Riders in English Equitation and Pleasure:**

- a. **A rider is classified as Junior until the end of the calendar year in which they turn 18.**
- b. **Junior C Riders are classified as Junior C such until the end of the calendar year in which they turn 12.**
- c. **Ages for English Pony classes are Junior and Junior C.**
- d. **Junior A riders may only show large.**
- e. **\*Ponies are animals that do not exceed 14.2 hands. Large ponies exceed 13.2 hands but do not exceed 14.2 hands. (Section A, General Regulations, Page 101).**

**MISCELLANEOUS JUMPER DIVISION:**

***See Equestrian Canada jumper rules. Junior, amateur or non-pro riders may not compete in draw reins or German martingales. G502. ## **MISCELLANEOUS HUNTER DIVISIONS**

*(not rated for EC awards)*

***Juniors of any age may show any height pony in miscellaneous classes. G306.3***

***Adults are permitted to show on large ponies in miscellaneous non-point classes not limited to Juniors. A pony shown in judged classes by an adult may not be shown in judged classes at the same competition. (G306.2)***

48. **Cross Rail Hunter** – A course of eight small cross rail fences. Horses to be judged on manners, obedience and style. The course may be trotted without penalty. Open to senior riding horses or large ponies and juniors riding horses or ponies of any height.
49. **Riders entered in the cross rail may not enter any other Hunter Divisions.**
  - a. 11) Cross Rail #1
  - b. 12) Cross Rail #2
  - c. 13) Cross Rail Under Saddle
50. **Intro Hunter** – Over fences: A simple hunter course of at least 8 fences with no combinations. Emphasis of judging on manners, obedience and style. Trotting to fences will not be penalized. Distances will not be adjusted for horses and ponies. Maximum height and width to be 22" (0.55m). Fences may be low verticals or oxers. Majority of fences to be 18" (.45m). Open to seniors riding horses or large ponies and juniors riding horses or ponies of any height.

  - b. 15) Intro Hunter #2

**Intro Hunter Under Saddle:** To be shown at walk, trot canter, both ways of the ring. No more than eight to hand-gallop at one time. In order to maintain awards, horses must compete and complete the course in at least one over fences class in their respective division, Article G319.1.

  - c. 16) Intro Hunter Under Saddle
51. Entries in this division are limited to Intro and Beginner Hunter Divisions. A pony ridden by an adult must not be shown by a junior in the same competition.
52. **Hunter Hack:** Horses may be asked to jump one or two fences not exceeding the division specifications. Horses may be asked to gallop but never more than eight at one time (pre-green and green horses not to gallop). In order to maintain awards, horses must compete and complete the course in at least one over fences class in their respective division. Hunter hack classes must never be the first class of a division.
  - a. 17) Hunter Hack
53. **Pre-beginner Hunter** - To complete a hunter-type jumping course of at least 8 obstacles not to exceed 2'3" (0.70m) in height. To be judged on obedience, jumping form and general way of going. The class is open to seniors riding horses or large ponies and juniors riding horses or ponies. The course may, but is not required, to be adjusted in height and distance for ponies. Juniors of any age may show any height of pony in miscellaneous, non-point classes. G306.2&3. A pony shown in judged classes by an adult may not be shown by a junior in a judged class at the same competition.
  - a. 18) Pre-beginner Hunter #1
  - b. 19) Pre-beginner Hunter #2
  - c. 20) Pre-beginner Under Saddle

54. **Beginner Hunter** - (To complete a hunter-type jumping course of at least 8 obstacles not to exceed 2'6 (0.75m) in height. To be judged on obedience, jumping form and general way of going. Open to seniors riding horses or large ponies and juniors riding horses or ponies. The course may, but not required to be adjusted in height and distance for ponies. Juniors of any age may show any height pony in miscellaneous non-point classes. G306. Adults are permitted to show on large ponies in miscellaneous non-point classes not limited to Juniors. A pony shown in judged classes by an adult may not be shown in judged classes by a junior at the same competition.
- a. 21) Beginner Hunter #1
  - b. 22) Beginner Hunter #2
  - c. 23) Beginner Hunter Under Saddle
55. **Entries in this division may enter Intro & Pre-Beginner Hunter, Pre-Beginner & Beginner OR Beginner & Low Hunter.**
56. **Heritage Low Hunter** - (0.85m) Open only to **horses** ridden by a Junior or Senior Rider. Horses judged on obedience, jumping form and general way of going.
- a. 24) Heritage Low Hunter #1

  - c. 26) Heritage Low Hunter Under Saddle

#### **EQUITATION DIVISION**

Equestrian Canada Rule Section G1001-1009

**Entry Fee: \$10 per class**

***Equitation classes are divided by age groups as follows: Individuals are juniors until the end of the calendar year in which they reach the age of 18. Article A901.***

***Routine on the flat: Article G1007. Riders will proceed at least once around the ring at each gait – walk, trot and canter, reverse and repeat. At the judge's discretion, they may be asked to execute an individual test.***

57. 29) Jr. "A" Hunter Seat (not to jump) Equestrian Canada. Riders are such from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year in which they reach the age of 18.
58. 30) Jr. "B" Hunter Seat (not to jump) Equine Canada. Riders are such from the beginning of the calendar year in which they reach the age of 13 until the end of the calendar year in which they reach the age of 15.
59. 31) J. "C" Hunter Seat (not to jump) Equestrian Canada. Riders are such until the end of the calendar year in which they reach the age of 12.
60. 32) Senior Amateur Hunter Seat (not to jump) Equestrian Canada



**ENGLISH HACK DIVISION**

**Entry Fee: \$10 per class**

***Equestrian Canada rules Section G Article G1301-G1304***

***English Pleasure (E.C.) Article G1303***

***Road Hack (E.C.) Article G1302***

***These 6 Hack Classes are all Equestrian Canada Point Classes***

- ***English Pleasure: To be shown at a flat-footed walk, normal trot and easy canter and not to gallop; light contact with the horse's mouth; to be judged on performance, manners and conformation.***
- ***Road Hack: Horses to enter ring at a walk. To be shown at a flat-footed walk with a reasonably loose rein, trot, strong trot, easy canter and hand gallop. Only 8 horses to hand gallop at one time. To be judged on performance, substance, conformation and manners.***
- ***Tack and personal appointments as per G1204 and G1205.***
- ***If ridden by a junior, heights of ponies and age of riders to be the same as in pony hunters. Junior C riders will be judged and pinned separately from Junior A & B riders in Junior classes if the classes are small.***

- 62. 42) Junior Road Hack,
- 63. 37) Senior English Pleasure
- 64. 43) Senior Road Hack
- 65. 38) Pony English Pleasure
- 66. 44) Pony Road Hack.

## ADDITIONAL MISCELLANEOUS DIVISIONS

*(not rated for EC awards)*

### **Walk/Trot Division – 12 yrs. and under Entry Fee: \$10 per class**

*(miscellaneous not rated for EC awards)*. Riders who enter the Walk/Trot Under 12 division may not cross enter, at the same competition, into classes which require the rider to canter or ride over fences.

67. 33) Walk/Trot Equitation: The class will proceed at least once around the ring at each gait – walk and trot and on command, reverse and repeat. Riders will then line up on command. The judge may ask questions about tack or horsemanship that would be suitable to the ability and age of the riders in the class. An individual test may be requested prior to the group class routine on the flat. This pattern may include a simple figure of eight pattern or similar simple pattern provided by the judge and posted at least one hour prior to the class. Riders who do not perform the individual test will not be eliminated and may proceed to the class routine on the flat.
68. 39) Walk/Trot English Pleasure: Open to horses or ponies.
- a. To be shown at a flat-footed walk and normal trot
  - b. To be judged on 45% performance, 40% manners and 15% conformation
69. 28) **Lead Line Entry Fee: \$10 per class**
- (miscellaneous class not rated for EC awards)*. This class is open to children under 10 and not entered in any other class. An EC Sport License is not required to enter this class. A Senior NBEA member must be holding the leadline and accompany the rider in the warm-up and competition rings.

### **NOVICE RIDER**

70. *Competitors in this competition are considered Novice if they are in their 1<sup>st</sup> or 2<sup>nd</sup> year showing at any competitions. (Miscellaneous Class not rated for EC awards)*
- a. 34) Novice Rider Equitation *(miscellaneous not rated for EC awards)* **walk/trot only** classes. Novice Riders may enter and compete in classes for novice riders only.
  - b. 40) Novice Rider English Pleasure *(miscellaneous not rated for EC awards)* **walk/trot only** classes. Novice Riders may enter and compete in classes for novice riders only.

### **GREEN HORSE**

71. *Horses in this competition are considered Green Horses if they are in their 1<sup>st</sup> or 2<sup>nd</sup> year of showing at any competitions. (Miscellaneous Class not rated for EC awards)*
- a. 35) Green Horse Equitation *(miscellaneous not rated for EC awards)* **walk/trot only** classes. Green horses may enter and compete in classes for green horse only.
  - b. 41) Green Horse English Pleasure an *(miscellaneous not rated for EC awards)* **walk/trot only** classes. Green horses may enter and compete in classes for green horse only.

## MISCELLANEOUS FUN CLASSES

(Not rated for EC awards)

72. The Command Class is neither a race nor is it a gymkhana event. It is a competition that exhibits the abilities of a well trained, responsive performance horse.
- Entries are eliminated, one at a time at the discretion of the judge as commands are not executed correctly. At no time are horses to be judged individually or one at a time to decide the class. At no time are ring stewards allowed to partake in the judging or placing of the class. The command to stop from the lope or hand gallop can be given only once in each direction.
  - Suggested commands are as follows: stop, trot, canter, reverse (at any gait), backup, 360° turn on the haunches, 180° turn on the forehand, side pass (left and right, counter canter, reverse, flying change of leads (no more than 8 horses), reverse simple change of leads (no more than 8 horses), roll back, walk, etc.
  - Examples of elimination are as follows: failure to execute the command correctly, wrong leads, disunited, excessive speed, breaking gait, hanging up or turning sideways at the back up, circling for better position without being commanded to do so, moving when stopped, etc. At the judge's discretion, entries may be eliminated for poor execution of the command, i.e. taking too long to execute transition from one gait to another, horse opening mouth excessively at the back up, etc.
    - a. 45) English Command – Open
73. Trail Class - This class will be judged on the performance of the horse over the obstacles, with emphasis on manners, response to the rider and quality of movement.
- At least six obstacles will be used, three of which will be mandatory and at least three others selected from the approved list. Gait between obstacles shall be at the discretion of the judge. The course to be used must be posted at least one hour before scheduled Failure to follow course shall cause elimination. Failure to complete obstacle shall not constitute elimination, but is to be severely penalized.
    - a. 46) English Trail
74. Carrot Race – following the Trail pattern, a rider will lead their horse, with a carrot, around various obstacles, in a set time. All horses / ponies must be wearing a halter and lead line.
- a. 47) Carrot Race
75. Costume Class – Shown at the walk only. Your costume must be designed to permit movement at the walk and to be safe for you, your horse and others around you. Please use caution and good judgement when creating costumes and keep SAFETY in mind.
- a. 48) Costume Class

**Directions to Geary Hill Stables:** To get to Geary Hill Stables take the Exit 303 at Oromocto. Keep to the right on Miramichi Road. Travel through the traffic circle past the Canadian Tire and keep to your right. As you near the 2nd traffic circle, travel to the right heading toward Geary. Follow Route 102 South toward Geary. You will come to a stop sign; make a right turning on to the Broad Road. Travel 6.5 km past an abandoned gas station on the left, over a small stone bridge, take the first right to the New Road. Travel approximately 0.75km and turn left at Geary Hill Stables Driveway at #31 New Road.

**Person Responsible:**

The Person Responsible (PR) for a horse must be an adult who has, or shares responsibility for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC Rules. The PR is liable under the penalty provisions of the applicable EC Rules for any rule violations. Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR. The Person Responsible is ultimately responsible for the condition, fitness and management of the horse and is alone responsible for any act performed by himself/herself or by any other person with authorized access to the horse in the stables, elsewhere on the grounds, or while the horse is being ridden, driven or exercised.

A: For adult entries into EC sanctioned competitions the PR shall be either the trainer, the owner of the horse or the competitor who rides or drives the horse during the EC sanctioned competition.

B: For Junior entries into EC sanctioned competitions the Junior competitor cannot be the PR. For Junior entries the PR may be either the trainer, the owner of the horse, or a parent/guardian of the Junior competitor.

Person Responsible (PR) must sign the competition entry form. PR must be an EC Sport License holder in good standing OR in the case of junior – minor owner, **a parent/guardian is entitled to sign as PR.**

**Parents and Guardians are entitled to sign their children’s entry forms without being EC members or holder of a Sport License, provided they agree to abide by the rules and penalties contained in the Rule Book. However, the owner of the horse must hold a valid EC Sport License and the owner’s EC Sport License number must be included on all entry forms.**

**NOTE: Person Responsible who are prevented from performing their duties by reason of illness or other cause, or who must be absent from any competition where horses under their care are entered and stabled shall immediately notify the competition secretary and at the same time, appoint a substitute. Such substitute Person Responsible shall place his or her name on the entry form forthwith and thereby shall assume full responsibility for the performance of the duties. The Person Responsible and the owner acknowledge that the Person Responsible represents the owner with respect to the horses entered in the competition in matters relating to entries, scratches for any reason, equine medication control and any act performed on any horse under the care and custody of the Person Responsible. For complete reference see Article A 1011. 1 c) and 2.**
