**How the Derby Works: Stadium and XC jumps are combined on the XC.** Sally is riding her horse in PE and E divisions. She will pay \$30 Facility fee + \$25 for her first round in PE, and \$5 for her second round in E. Sally pays \$55 total. Jane is riding 2 E courses and then if it all goes well, will add PT later. Jane will pay \$30 Facility fee + \$25 first round, \$5 second round and pays \$55 before she rides. Then, if she does the PT round she pays another \$5 at registration. For fairness to placings aare based on the higher division you ride in and you can only place in one division. Organizers have the right to refuse a second round for a horse that is too unfit or does not demonstrate sufficient ability. Equine Canada rules and regulations followed.

**There is time to walk xc before each division. Day starts with PE. Divisional times to be posted to provide rough estimate of rider times. Check what you wish to ride:**

- Pre-Entry (2'6"): Number of rounds at PE \_\_\_\_\_

I acknowledge that the sport of Eventing is a high-risk sport and that I am participating at my own risk and in full knowledge of the hazards and potential hazards which are inherent in this sport. I further acknowledge the inherent risk in riding and working around horses, which risks include bodily injury to both horse and rider which can result from normal use, competition or schooling. It is hereby recognized that no helmet or protective equipment can fully protect the rider or horse against all injuries that may be suffered arising from the acknowledged risks.

3. I hereby certify that every horse, Rider and/or driver is eligible as entered and agree for myself and my representatives to be bound by the Constitution and Rules of Equine Canada at this competition. In the event that the competitor participates in a competition where approved headgear is required he/she will wear properly fitted, approved protective headgear complying with European (EN), British (PAS) North American (ASTM) and Australian/New Zealand testing standards. It is understood that competitors not meeting this requirement will not be allowed to compete at these sanctioned competitions.

4. As an **adult** participant, and in consideration of being allowed to participate in this event (or as an Owner or as the Person Responsible for the horse - as the case may be) I hereby assume all risks associated with participation or involvement in the event and I hereby release and save harmless the Organizing Committee, the Canadian Eventing Committee (C.E.) , Brae Fearann Eventing and Equestrian Facility and its volunteers, Directors, representatives, and independent contractors as well as the owners and occupiers of the land upon which the competition is held (the Released Parties) from all responsibility, liability or claims of any nature and kind which I may have against the Released Parties arising from my participation or involvement in this event or from my horses participation or involvement at this event, including but not limited to bodily injury or death to myself or my horse(s) and damage to property arising from any cause whatever, **including the negligence of one or more of the Released Parties.**
