WE HAVE PRINCIPLES

Statement of Principle

Equestrian Canada (EC), the national equestrian federation of Canada, supports adherence to the humane treatment of horses in all activities under its jurisdiction.

All Persons shall be committed to:

- Upholding the welfare of all horses, regardless of value, as a primary consideration in all activities;
- Requiring that horses be treated with kindness, respect and compassion, and that they never be subjected to mistreatment;
- Ensuring that all equestrians including owners, trainer and competitors, or their respective agents, use responsible care in the handling, treatment and transportation of their own horses as well as horses placed in their care for any purpose;
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety as a matter of standard operating procedure;
- Providing current information on Code of Practice for the Care and Handling of Equines and other equine health and welfare initiatives;
- Continuing to support scientific studies on equine health and welfare;
- Requiring owners, trainers and competitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competitions; and
- Actively promoting the development and adherence of competition rules and regulations that protect the welfare of the horse.

The standards by which conduct, or treatment will be measured is that which a person who is informed and experienced in generally accepted equine training and competition procedures would determine to be neither cruel, abusive, nor inhumane.



ALL THE RULES

Show Rules

- All entry forms due no later than five (5) days prior to the show as entries may need to be limited in some classes for safety and management purposes.
- Any late entries received after 5 days prior to the show date will be charged an additional administration fee of \$35.00 per horse.
- All information must be completed, and all forms signed for the entry to be accepted. Photos of show forms will not be accepted – please scan, fax, mail, or drop off entries.
- Drop off or mail show forms to: Foshay South Eventing, 21 Gallagher Road, Lakeside, NB, E5N 7K2.
- Email and faxed entries are accepted with credit card or e-transfer payment. A 5% of total cost processing fee will be applied with credit card payments. Email: suzannestevenson@nb.sympatico.ca; Fax: 506-696-4403. Please email in advance of sending faxes to ensure they are received.
- Make all cheques payable to “Foshay South Eventing Inc”. NSF cheques will be charged \$50 administration fee. No post-dated cheques will be accepted. Credit cards accepted include Visa and Mastercard.
- All payment must accompany entry form(s).
- A copy of Bronze or Gold sport license, NBEA membership, negative coggins (within 1 year) and proof of vaccinations (Flu, Rhino, Tetanus, and Strangles) must be sent in with the entry form(s).
- All entries must be made in writing (Article A801.4). The show number will not be issued if all the required signature are not complete.
- Jumper Classes are paid for on a class basis.
- Post entries will be accepted up to one hour prior to the class and will be subject to an additional \$5 charge per class.
- Scratches will not be reimbursed.
- Official protests must be made in writing to the secretary of the competition, signed and accompanied by a \$100.00 cash deposit within 48 hours of completion of the class (EC Article A1204).
- Competition number must be worn and visible at all times anywhere out of the stables at the event location, whether the horse is being hand walked or ridden. (Secton G, Annex 1, page 101 1.2)
- Every class offered herein is covered by the rules and specifications of the current rules of Equestrian Canada and will be held and judged in accordance with the Equestrian Canada Rule Book. Any incident requiring a ruling which cannot be referenced to the EC Rule Book, will be rendered by the Show Committee.

All THE RULES- PT. 2

- If less than four entries are received for any class, the show committee reserves the right to cancel or combine classes.
- Entry forms must be signed by exhibitor, owner and person responsible. If the owner or exhibitor is under 19 years of age as of January first, the entry must be signed by a parent or legal guardian who assumes all responsibility and risk as stated on the form and by these rules and regulations. The entry form for all sanctioned competitions shall also be signed by the person responsible for the care, training, custody and performance of the horse. The person responsible may be the trainer, owner, rider, agent, or coach. The parent or guardian must sign the entry form as person responsible for the minor/owner if there is no other person responsible. The person responsible is to be present at the competition and if they cannot attend, must appoint a representative who is present on the show grounds and must notify the competition secretary. Article A1011 – The person responsible who signs an entry form must hold an EC or USEF individual sport license except parent/guardian.
- Management has the right to expel any rider, owner or spectator deemed to be in their sole discretion disruptive to the show at any time.
- Dogs must be leashed or caged while on the show grounds. The Owners are solely and expressly responsible for their dogs and the dog's behavior. Owners of loose dogs will be charged \$75.00 to retrieve their pets.
- Absolutely "NO" smoking or vaping permitted on show grounds.
- The show office will open one (1) hour prior to the start of the show and close ½ hour at the end of the show. It is located in the green building by the arena.
- Bronze classes do not require EC Horse Recording or Jump Canada Levy. Bronze Sport Licenses are required for all Bronze classes and can be purchased at www.equestrian.ca. They will also be for sale at the show office on the day of the show.
- Substitutions: A horse/pony may compete with a substitute athlete providing the athlete is eligible to enter the class and pays any substitution fee required by the show organizer. An athlete may compete with a substitute horse/pony providing the horse/pony is eligible to enter the class and the athlete pays any substitution fee required by the show organizer. The substitution fee required to substitute horse/pony or athlete is \$50 after the closing date. If the substitution is requested after the start of the competition, the show committee reserves the right to refuse. As per EC rule A805.3, the show committee reserves the right to refuse any entry, except as provided in A805.2.

WHAT WE OFFER

Services Offered

- Stabling is available at a charge of \$50/night. Stabling will only become available on Sunday afternoon.
- Hay is available at \$7.00 per bale.
- Warm up area will be available on the show grounds.
- Ring size: 470' x 310'
- There will be a variety of food vendors on site as well as some vendors from Foshay International's Country Market.
- Warm up classes will only be available on Monday morning for the 0.60m Jumper divisions. Riders are encouraged to enter the previous height class as a warm up round.

Exhibitor Requirements

- Equestrian Canada Bronze Sport License and NBEA membership are required to compete in Bronze classes. For the Gold classes, an Equestrian Canada Gold Sport License and NBEA membership are required to compete in Gold classes.
- Exhibitors are to send a photocopy of the rider's Equestrian Canada and owner's Equestrian Canada number as well as NBEA membership with the entry form.
- Bronze and Gold Sport Licence may be purchased online at www.equestrian.ca. Your receipt will be proof of sport licence. Temporary one-day sport licences are no longer available for Bronze. Gold sport licences may be purchased through the competition office. Single event upgrades may be purchased through the competition office (A211).

THE NITTY GRITTY ON SAFETY

Safety Rules

1. HEADGEAR (Article G102)

a. At all EC-sanctioned competitions, all competitors, including foreign competitors in EC National classes, must wear approved headgear, with safety harness correctly fastened, at all times while mounted on the competition grounds.

b. Juniors showing any horse in a jog for soundness must wear approved protective headwear with the attached safety harness fastened.

c. Failure to comply with G102.1 in the exercise area and/or the competition arena will result in the following penalties:

i. First violation: warning

ii. Second violation (at the same competition): disqualification from the competition and forfeiture of all fees and prize monies.

d. EC makes no representation or warranty expressed or implied about any protective headgear and cautions riders that serious injury or death may result despite wearing such headgear as all equestrian sports involved inherent dangerous risk and adds no protective helmet can protect against all foreseeable injuries.

e. All violations which occur outside the competition arena will be reported to the judge/jury who will levy the applicable penalty.

f. All violation which occur in the competition arena will be acted upon by the judge(s) who will levy the applicable penalty.

g. For all competitors, if the harness comes undone or the hat falls off, the rider must retrieve and/or do up the hat, with assistance if necessary, before the next obstacle is taken. There will be no penalty other than the loss of time. Failure to do up the harness or retrieve protective headgear immediately results in elimination.

SAFETY RULES- PT.2

2. The show committee does not accept responsibility for accidents or illness to horses, riders, grooms, spectators or any other persons.

3. Exhibitors competing for provincial points are requested to enter the animal in the name of the member of the family who is the official Equestrian Canada member.

4. EMERGENCY MEDICAL SERVICES (Article G101)

It is mandatory that all national and provincial competitions have on site emergency medical services with a minimum of advanced first aid and basic cardiac life support (BCLS). Jumping in competition and warm-up areas should be suspended if the sole medic onsite is handling an emergency she/he cannot leave.

5. FALLS (Article G103)

After being eliminated for a fall, the rider may not remount in the ring. Any rider who does remount in the ring after a fall will be eliminated from all classes in the ring for the remainder of the day. A rider who remounts after a fall and takes another obstacle will be disqualified from the remainder of the show.

6. IN-GATE (Article G104)

In all classes, trotting or cantering through the in-gate without prior permission is forbidden. The penalty for contravening this rule is either a fine or elimination from the class, at the discretion of the judge. Under special circumstances, a steward or judge may give permission for a horse to trot into the ring, but not out of the ring.

7. STALLIONS (Article G105)

Junior B and C riders must not ride or handle stallions anywhere on the competition grounds. Junior A riders may ride manageable stallions in jumper classes only. Manageable stallions ridden by seniors are eligible for all senior classes. A stallion ridden by a junior must be accompanied at all times by a competent adult/handler Person Responsible.

8. HORS CONCOURS (Article A808 and G501)

"Hors Concours" entries may be accepted at the competition committee's discretion but are subject to the same scoring rules as a regular entry with respect to falls, elimination, etc. Such entries are not judged and are not eligible for the jump-off. A horse or pony that has competed "Hors Concours" is not allowed to compete subsequently in the same ring on the same day. A horse or pony may only compete "Hors Concours" once in the same ring on the same day. "Hors Concours" entries will follow the last regular entry in the class.

9. Cell phones, iPods, etc., are not recommended to be used while riding (See Article G114 COMMUNICATION)

10. Any horse that becomes out of control shall be eliminated from the competition at the discretion of the judge.

11. Lunging will not be permitted in the warm-up ring if there is more than one rider in the ring.

12. Schooling Rules: reference Hunter/Jumper schooling rules see Annex 1, p.101, Section G rule book. FEI schooling rules will be in force. Per Article A801, every entry at an EC sanctioned competition shall constitute and agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC Constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition.

GOLD AND BRONZE- WHAT'S THE DIFFERENCE?

BRONZE SECTION OF HORSE SHOW

New Brunswick Bronze competitors require an NBEA membership. Bronze Membership may be purchased from Equestrian Canada (www.equestrian.ca) – printed receipt will be accepted for proof of Equestrian Canada membership. EC Horse Recordings and Jump Canada Levy are not required for Bronze classes. Bronze classes will count as qualifiers for the 2019 NBEA Hunter/Jumper Bronze Championships. GOLD SECTION OF HORSE SHOW

New Brunswick riders must have an NBEA membership. Gold Competition Sport License must be purchased from Equestrian Canada – printed receipt will be accepted as proof of membership. Horses must have an EC Horse Recording and have paid the annual EC horse recording activation fee to compete, which can be purchased from Equestrian Canada. If the owner purchases a temporary sport license, a temporary horse registration must be purchased. If a Horse Recording cannot be produced, the person responsible must complete a temporary horse registration form and pay the temporary registration fee (A410.2). Foreign entries must sign an affidavit (Article A404).
