



## 2024 New Brunswick Equestrian Association Competition Officials/Biosecurity Funding Program

### Preamble

NBEA is a strong supporter of nationally sanctioned competitions. We thank the horse show organizers, and aim to assist with expenses incurred by bringing senior officials from other parts of Canada. In addition, we hope to strengthen biosecurity practices at New Brunswick competitions by support those that make vaccines and Coggins mandatory for all horse entered.

### Important reminder

- **ARTICLE A602 PRIZE LISTS – MANDATORY INFORMATION (8.)** *The following statement must be included in the prize list of any EC sanctioned competition: "All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations."*
- **ARTICLE A802 ENTRY FORMS (7.)** *All entry forms must contain the following statement, which must be signed by the person(s) responsible (See Glossary – Person(s) responsible): "I hereby certify that every horse listed on this entry form has met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations."*

**ARTICLE A519 VACCINATIONS** All horses attending Equestrian Canada sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave event site at the discretion of Competition Management.

The frequency of vaccine administration should be as recommended by the vaccine manufacturer or veterinarian. It is recommended that vaccines be administered by or under the direction of a veterinarian. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements. 2020 Rules of Equestrian Canada Section A Page 25

In the case of a horse that is unable to receive either of the vaccines, a letter from a veterinarian on official letterhead must be provided with the entry form, stating the horse cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested.

The NBEA position on biosecurity has not wavered and we want to support horse show organizers as leaders in protecting the NB horse herd that are in a high risk of contracting diseases.

*To be eligible for funding, competitions must meet the **NBEA Biosecurity requirements:***

- EC-mandated vaccinations – equine herpesvirus (1 & 4) (**EHV -1 and 4**), equine influenza (**flu**)
- Also: streptococcus equi (**strangles**) and a negative **Coggin's test\***

Vaccines must be administered within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event.

*The competition's approved prize list (or link to online copy) denoting the EC rule and the additional requirement of strangles and Coggins must accompany this application.*

\*Individual competitions may require more vaccinations for its competitors, but these are the minimum required to be eligible for NBEA funding.

**Gold, Silver, Bronze – 100% of the Judge's officiating fee,  
up to a maximum of \$400.**

**New Bronze competitions – 100% the Steward's officiating fee**

*Note: a signed invoice or receipt from the competition official(s) showing the per diem officiating fees must accompany the application for funding.*

*Applications must be received within 10 days of the competition.*

**The NBEA is funding the officiating fee only. Expenses are not included.**
