\$30,000 Accidental Death & Dismemberment

(AD&D) providing 24/7, worldwide coverage for catastrophic and permanent injury (or death) arising from equine related activities.

***Fracture, Dental and loss of income claims are not included.**

Members Named Perils

Insures your horse(s) for death arising from specific causes such as fire or lightning, transportation, earthquake or flood, or attack by dogs or wild animals. Limit \$10,000

NEW for 2018 - Starting January 1, 2018, the Members Named Perils policy will include compensation for government ordered destruction of a horse

Members Tack

Insures tack and equipment from loss or damage anywhere in Continental US/Canada. Limit \$10,000-\$500 Deductible

Accidental Death & Dismemberment*

In addition to your "included" \$30,000 principal sum you can now purchase an additional \$50,000 coverage that includes benefits for Fracture and Dental injuries.

**Optional Accidental Death & Dismemberment (AD&D) coverage is restricted to members who have not reached the age of 75 years.*

Travel Medical*

Provides \$2,000,000 out of province and country coverage for Medical treatments and/or Hospitalization. Trips up to 90 days in duration, any number of trips per year, worldwide.

**Optional Travel coverage is restricted to members who have not reached the age of 75 years.*

Weekly Accidental Indemnity (Short Term Disability)

This coverage can provide you with income replacement for up to 26 weeks if you are unable to work due to an accident.
