# **Statement of Principles**

Equine Canada (EC), the national equestrian federation of Canada, supports adherence to the humane treatment of horses in all activities under its jurisdiction.

EC is committed to:

- upholding the welfare of all horses, regardless of value, as a primary consideration in all activities;
- requiring that horses be treated with kindness, respect and compassion, and that they never be subjected to mistreatment;
- ensuring that owners, trainers and competitors, or their agents use responsible care in the handling, treatment and transportation of their own horses as well as horses placed in their care for any purpose;
- providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure;
- providing current information on Code of Practice for the Care and Handling of Equines and other equine health and welfare initiatives ;
- continuing to support scientific studies on equine health and welfare;
- requiring owners, trainers and competitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competition; and
- reviewing, revising and developing competition rules and regulations that protect the welfare of the horse.

The Standard by which conduct or treatment will be measured is that which a person, informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive, nor inhumane.

#### **GENERAL RULES**

- 2. Show Office opens at 7:30 am and will remain open to accept post entries during the show. Post entries must be received at least <u>3 classes before</u> the class is to start and payment is to be received at that time.
- 3. <u>Limited stabling for out of town exhibitors only</u>. Please contact the show manager or secretary for those interested. \$30.00 per stall.
- 4. Show Committee Members are: Krista Grant-Demetre, Ellen Dunphy & Sarah Noel
- 5. The show committee has the right to refuse any entry that is not in good standing with NBEA, Equine Canada or competition venue.
- 6. This EC-sanctioned competition and all its competitors shall be governed by the current rules of EC. General Regulations and Rule Book for General Performance may be read on EC website. Rulebooks may be purchased from the NBEA.
- 7. Each horse/rider combination must submit separate entries. <u>All entries must be</u> <u>complete and signed before numbers will be issued.</u>
- 8. Entry fees are \$10.00 per class, \$20.00 per Jumper Division and \$25.00 Hunter Divisions entered. **Payment must be received with all entries.**
- 9. All cheques are to be made payable to: Capital Zone 3 Horse Show. (No post dated cheques)
- 10. Post entries are permitted the day of the show and must be received at least 3 classes before the class is to start.
- 11. Competitors are allowed to enter only <u>two</u> Jumper Divisions or Over Fences Hunter Divisions.

Examples: Jumper: 0.75m (2'6)/0.85m (2'9) or 0.85m (2'9)/0.90m (3'0) Hunter: Intro /Beginner or Beginner/ Low

## \*Jump offs will immediately follow each division

Jumper classes are a timed event. Riders are permitted to walk the course. Elimations - for falls off horse, rider or both in class; second refusal or exceeding the time limit. \*Riders may jump one single obstacle after elimination providing it is part of the course and it is not due to a fall. (Section F page 50)

- 12. Riders entering the Cross Rail Division are not permitted to enter any other Over Fences Hunter Division.
- 13. Heights or distances of the jumps will not be adjusted for ponies.\*Maximum height for ponies in Hunter classes is 2'6"
- 14. Hors concours is not permitted in Hunter classes. (G201) Hors Concours entries may be accepted at the competition committee's discretion but are subject to the same scoring rules as a regular entry with respect to falls, elimination etc. Such entries are not judged and are not eligible for the jump off. A horse or pony that has competed Hors Concours is not allowed to compete subsequently in the same ring on the same day.
- 15. Cash prizes for all 1<sup>st</sup> place winners, prizes for 2<sup>nd</sup> & 3<sup>rd</sup> place. Ribbons presented from 1<sup>st</sup> to 5<sup>th</sup> place
- 16. Judges decision is final.



- 17. Entries must be received by <u>June 20, 2015.</u> All late entries will be subject to a <u>\$35.00 late fee</u>.
- 18. All riders are required to wear protective helmets that are ASTM approved with a fixed harness while mounted anywhere on the show grounds. This rule applies to English and Western riders.
- 19. Any horse entered in any class at this competition may be selected for equine medication control testing while at the event location.

## 20. All entries must attach a copy of the following: NO EXCEPTIONS

Proof of <u>current year</u> vaccinations & <u>COGGINS within 1 year of the show</u> <u>date.</u> \*mandatory vaccinations are tetanus, flu, rabies, rhino & strangles

-2015 EC Bronze Sport License (or higher) Bronze EC memberships may be purchased from EC at <u>www.equinecanada.ca</u> (*Lead line class is exempted from EC Sport License requirements.*)

-2015 NBEA Membership -All riders including those schooling horses on the competition grounds must also be NBEA members.

- 21. Cross Entries where permitted in the rules are permitted.
- 22. Protests must be made in writing and addressed to the secretary of the competition at which the matter under consideration occurs, must be signed and must be accompanied by a deposit of \$100 cash within 48 hours of the competition. See conditions for complaints and protest of rule book Section A General Regulations

## 23. Age Divisions (WESTERN): As of January 1<sup>st</sup> 2015

\*Small Fry – under 12 years of age Youth 13 years and younger Junior – 14-18 years of age \*Individuals are juniors until the end of the calendar year in which they turn 18. Senior - 18 years of age and older

Western pony classes are open to Youth and Junior Competitors.

**\*Miscellaneous division**: Riders entered in Small Fry division may only compete in Small Fry division at this competition. Small Fry is **walk/trot only** and does not have year-end awards.

- 24. Competitors in this competition are considered Novice if they are in their 1<sup>st</sup> or 2<sup>nd</sup> year showing at any competitions. (Miscellaneous Class)
- 25. Horses in this competition are considered Green Horses if they are in their 1<sup>st</sup> or 2<sup>nd</sup> year of showing at any competitions. (Miscellaneous Class)
- 26. Stallions are not permitted
- 27. Ring numbers must be worn and visible at all times in the schooling and exercise areas as well as in the competition ring.
- 28. The show will forfeit 75% of the entry fee less the fees for classes completed if the horse entered is withdrawn due to unsoundness or illness provided a veterinarian's certificate is produced, dated not later than the closing day of the show and received within 10 days of the show date.
- 29. Any actions towards a horse deemed abusive or excessive by a judge, steward or show committee members by an exhibitor or anyone anywhere on show grounds may be given an official warning or may disqualified from the competition. Article A517
- 30. The Show Committee, its officials, volunteers or Geary Hill Stables does not assume responsibility for accidents or illness to horses, riders, spectators or any other persons in attendance.
- 31. Classes with less than 3 entries may be combined or cancelled at the discretion of the show committee.

32. Novice Rider and Green Horse (miscellaneous classes) are **walk/trot only** classes. Novice Riders may enter and compete in classes for <u>novice riders only</u>.

# Riders under 12 years of age who wish to enter walk/trot classes must compete in Small Fry classes.

Classes #21, 27, 61 and 66 will have riders compete in Novice Rider or Green Horse and will <u>run separately</u>. Please indicate on your entry form the class # and if you are entering Novice Rider or Green Horse.

- 33. EC rule book is available on the Equine Canada website at: <u>www.equinecanada.ca</u> and a hard copy will be on site the day of the horse show. Any questions regarding EC rules and regulations please contact our show Steward Francine White at gwfw@rogers.com. The competition will be conducted under the rules of EC General Performance Section F. Miscellaneous class descriptions are provided in the Prize List.
- 34. Each horse/rider combination is allowed to enter a maximum of <u>15</u> under saddle classes.
- 35. Lunging will not be permitted in warm-up area if there are riders warming up. Lunging can be permitted <u>before</u> 7:30 am. Warm up open to riders after 7:30 am. No more than two people may lunge at one time.
- 36. NO SMOKING anywhere on the competition grounds.
- 37. Dogs must be on a leash <u>at all times</u> while on the show grounds.
- 38. Every class offered herein is covered by the rules and specifications of the current rules of Equine Canada and will be held and judged in accordance with the Equine Canada Rule Book. Any incident requiring a ruling which cannot be referenced to the EC Rule Book, will be rendered by the Show Committee.

## Ages for Riders in English Equitation and Pleasure:

-A rider is classified as Junior until the end of the calendar year in which they turn 18.

-Junior C Riders are classified as Junior C such until the end of the calendar year in which they turn 12.

Ages for English Pony classes are Junior and Junior C. Junior A riders may only show large ponies. \*Ponies are animals that do not exceed 14.2 hands. Large ponies exceed 13.2 hands but do not exceed 14.2 hands. (Section A General Regulations Page 105)

## **Miscellaneous Hunter Divisions:**

Juniors of any age may show any height pony in miscellaneous classes.

Adults are permitted to show on large ponies in miscellaneous non-point classes not limited to Juniors. <u>A pony shown in judged classes by an adult may not be</u> <u>shown in judged classes at the same competition</u>. (G306)

**Cross Rail Hunter** – A course of eight small cross rail fences. Horses to be judged on manners, obedience and style. The course may be trotted without penalty. Open to senior riding horses or large ponies and juniors riding horses or ponies of any height.

Riders entered in the cross rail may not enter any other Hunter Divisions.

**Intro Hunter** – Over fences: A simple hunter course of at least 8 fences with no combinations. Emphasis of judging on manners, obedience and style. Trotting to fences will not be penalized. Distances will not be adjusted for horses and ponies. Maximum height and width to be 22" (0.55m) Fences may be low verticals or oxers. Majority of fences to be 18" (0.45m) Open to seniors riding horses or large ponies and juniors riding horses or ponies of any height.

46) Intro Hunter #147) Intro Hunter #2

**Intro Hunter Under Saddle**: To be shown at walk, trot canter, both ways of the ring. No more than eight to hand-gallop at one time. To be eligible horses/ponies must have completed the course in at least one fences class in their prospective division. 53) Intro Hunter Under Saddle

Entries in this division are limited to Intro and Beginner Hunter Divisions. A pony ridden by an adult must not be shown by a junior in the same competition.

**Beginner Hunter** - (To complete a hunter-type jumping course of at least 8 obstacles not to exceed 2'6 (0.75m) in height. To be judged on obedience, jumping form and general way of going. Open to seniors riding horses or large ponies and juniors riding horses or ponies. The course may, but not required to be adjusted in height and distance for ponies. Juniors of any age may show any height pony in miscellaneous non-point classes. G306. Adults are permitted to show on large ponies in miscellaneous non-point classes not limited to Juniors. A pony shown in judged classes by an adult may not be shown in judged classes by a junior at the same competition.

**Directions to Geary Hill Stables**: To get to Geary Hill Stables take the Exit 303 at Oromocto. Keep to the right on Miramichi Road. # If the rider is under 18 years of age, the parent or guardian must complete the areas requiring name, date and signature. <u>PLEASE READ CAREFULLY</u>

#### **Person Responsible:**

The Person Responsible for a horse must be an adult who has, or shares, responsibility for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC Rules and is liable under the penalty provisions of the Rules for any violation of the EC Rules. For the purpose of these Rules, the Person Responsible is normally the trainer, owner or the competitor who rides or drives the horse during an event, or a parent or legal guardian in the case of junior competitors. The Person Responsible is ultimately responsible for the condition, fitness and management of the horse and is alone responsible for any act performed in the stables by himself or herself or by any other person with authorized access to the horse, or while the horse is being ridden, driven or exercised. The Person Responsible must hold a valid EC Sport License in good standing at the same level or higher in which the horse is competing. *However, when the competitor is a Junior, the competitor cannot be the Person Responsible and the Person Responsible may be a parent/guardian who must be at minimum an EC or USEF member in good standing. The entry form must list the Person Responsible's name, their EC or USEF member number and be signed.* (NOTE: If you are a current member of the NBEA you may purchase a EC Membership for \$10.00 at www.equinecanda.ca.)

Parents and Guardians are entitled to sign their children's entry forms without being EC members or holder of a Sport License, provided they agree to abide by the rules and penalties contained in the Rule Book. However, the owner of the horse must hold a valid EC Sport License and the owner's EC Sport License number must be included on all entry forms.

NOTE: Person Responsible who are prevented from performing their duties by reason of illness or other cause, or who must be absent from any competition where horses under their care are entered and stabled shall immediately notify the competition secretary and at the same time, appoint a substitute. Such substitute Person Responsible shall place his or her name on the entry form forthwith and thereby shall assume full responsibility for the performance of the duties. The Person Responsible and the owner acknowledge that the Person Responsible represents the owner with respect to the horses entered in the competition in matters relating to entries, scratches for any reason, equine medication control and any act performed on any horse under the care and custody of the Person Responsible. For complete reference see Article A 1011 1 c) and 2.
