

2019 New Brunswick Equestrian Association Competition Officials/Biosecurity Funding Program

Preamble

NBEA is a great supporter of nationally sanctioned competitions. We thank the horse show organizers, and aim to assist with expenses incurred by bringing senior officials from other parts of Canada. The officials funding of the past has, I hope, helped with this financial burden.

However, in 2019, to receive the increased funding percentages, competition organizers must make vaccines and Coggins mandatory for all horse entered in your competition. We have listed the minimum and we know some of you will be asking for more. Please communicate this with your members and the NBEA will remind exhibitors to read each competition's prize list for needed vaccines.

The NBEA position on biosecurity has not wavered and we want to support horse show organizers as leaders in protecting the NB horse herd that are in a high risk of contracting diseases. To be eligible for funding, competitions must meet the NBEA Biosecurity requirements by making *at least* the following vaccinations mandatory for competitors – equine herpesvirus (**rhino**), equine influenza (**flu**) and streptococcus equi (**strangles**). A negative **Coggin's test** is also mandatory.

The competition's approved prize list (or link to online copy) denoting this requirement must accompany the application. (This replaces the former Biosecurity Funding Program.)

Eligible competitions will receive funding at the following rates:

Gold - 40% of the Judge's officiating fee Silver - 35% of the Judge's officiating fee Bronze - 30% of the Judge's officiating fee New Bronze competitions – 100% the Steward's officiating fee.

Minimum required vaccinations: *rhino, flu, strangles, plus negative Coggins test*
