The Capital Zone Combined Test is sanctioned as a Bronze competition members of Equestrian Canada (EC), 11 Hines Road, Suite 201, Ottawa, Ontario, K2K2X1 and is governed by the rules of EC. Every class offered herein is covered by the current rules and specifications of EC and will be held and judged in accordance with the EC Rule Book.

## **Equestrian Canada**

### **Statement of Principles**

Equestrian Canada (EC), the national equestrian federation of Canada, supports adherence to humane treatment of horses in all activities under its jurisdiction.

All persons shall be committed to:

- Upholding the welfare of horses, regardless of value, as a primary consideration in all activities.
- Requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to mistreatment.
- Ensuring that all equestrians including owners, trainers and competitors and their respective agents use responsible care in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose.
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professional and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure.
- Continuing to support scientific studies on equine health and welfare.
- Requiring that owners, trainers and competitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions
- Reviewing, revising and developing competition rules and regulations that protect the welfare of the horses.
- The standard by which conduct, or treatment will be measured is that which a person, informed and experienced in generally accepted equine training and competition procedures, would determine to be neither cruel, abusive nor inhuman.

### **COVID-19 Rules and Regulations:**

- PLEASE BRING A MASK – they will be necessary when coming to the show office!
- Keep your 2m distance, including when parking trailers and grazing horses.
- If you cannot keep your 2m distance, please put on your mask.
- Sanitize/Wash your hands frequently. A hand washing station will be on-site.
- Do not share supplies, water buckets, etc.
- Please limit the number of spectators/grooms.
- Please bring your own lunch/snack/beverages as there will be no canteen available this year.
- Covid – 19 Daily Attestation forms must be signed each day by the rider/PR. All other persons on site (including spectators) will need to sign the Covid – 19 Event Participation Waiver.
- Each person must exit through the main gate checkpoint and notify the attendant that they are leaving the show grounds.
- All competitors MUST leave the grounds once their portion of the show has ended.

### Show Rules and Regulations:

- Porta-Pottie will be on site.
- Ribbons from 1<sup>st</sup> to 6<sup>th</sup>. They can be picked up at the show office 30min after the completion of the class.
- Ride Times will be emailed two days prior to the horse show.
- Show office will open 1 hour before the first test and will remain open 1 hour after the last test.
- Riders are required to have a HTNB membership in addition to an EC and NBEA membership. Riders can purchase these for \$20 through <https://htnb.org/membership/>
- No post entries will be accepted.
- Scratches will not be reimbursed.

### What is a Combined Test?

A combined test is part of the Eventing discipline. It requires a horse/rider combination to complete 2 phases of a horse trial. This show will be comprised of a dressage phase and a stadium jumping phase. Dressage tests are predetermined (see below) and are ridden in a 20x40m ring. They will then complete a jumping phase. The two phases are scored together (see below for scoring info) #D203.3.2.

### Combined Test Scoring:

Riders will first complete the dressage phase. The dressage score is converted into penalty points. This is done by subtracting your percentage score from 100 (ex:  $100 - 62.8 = 37.2$ )

In the stadium jumping phase, riders may receive penalty points via rails (same as faults in Show Jumping) and penalty points for time. Time penalties are added for exceeding the time allowed at the Pre-Entry, Entry, and Pre-Training Levels. For each second or part second over the time allowed, the rider will accrue  $\frac{1}{4}$  time penalty. Riders who exceed the time limit (x2 the time allowed) will be eliminated, and riders are not rewarded for completing in less than the time allowed.

Riders are awarded ribbons for the overall score, not for each phase.

### Capital Zone Combined Test

The Combined Test entries will be scheduled after the dressage tests, most likely in the afternoon depending on entries. This will allow us to modify the dressage ring from a 20x60 to a 20x40m.

#### DRESSAGE PHASE: 20mx40m sand ring

- Starter → Entry Test #1
- Pre-Entry → Entry Test #1
- Entry → Entry Test #2
- Pre-Training → Pre-Training Test #2
- Training → Training Test #2

#### JUMPING PHASE: \*Table C, FEI Article 239

- Starter → 0.60m Jumper Speed
- Pre-Entry → 0.75m Jumper Speed
- Entry → 0.80m Jumper Speed
- Pre-Training → 0.90m Jumper Speed
- Training → 1.0m Jumper Speed

Rider can choose to only ride one phase of the combined test (either jumping or dressage) or compete in both to be considered for a division in the Combined Test. Riders who do not complete both phases of the same division will not be eligible for prizes, including ribbons.

**Entries:**

- Late entries will NOT be accepted.

As per Equestrian Canada rule article A805, the Show Committee reserves the right to refuse any entry, except as provided in 805.2 (a, b, c, d, e). The competition may refuse any entry failing to comply with the Prize List regulations or any competitor or owner who is determined to have failed to adhere to the standard of sportsmanship behaviour outlined in the Code of Conduct (A805.3).

**Divisions & Classes:**

Starter – Training will be offered.

Dressage Phases will be first, followed by the stadium jumping phase.

**Ring Size:**

Dressage tests will be ridden in a 20m x 40m sand ring.

Warm up ring will also be available.

**Ring Numbers:**

Ring numbers must be worn by the horse or rider/handler anywhere outside of the stall from the time that the number is issued until the end of the competition to allow officials to identify the horse (D107.1).

**Lunging:**

Lunging is not permitted in an area where horses are being ridden. Lunging (unmounted) and work in hand may only be done by the athlete, owner, coach, groom or Person Responsible. It is not permitted to lunge a mounted horse at any competition site whether or not the horse is entered in the competition (D107.7).

**Hors Concours:**

Hors Concours will not be allowed during the show. This is due to the established ride time schedule and limiting the time on-site due to Covid-19. Thank you for your understanding.

**Substitutions:**

A horse/pony may compete with a substitute athlete providing the athlete is eligible to enter the class and pays any substitution fee required by the show organizer. An athlete may compete with a substitute horse/pony providing the horse/pony is eligible to enter the class and the athlete pays any substitution fee required by the show organizer. The substitution fee required to substitute

horse/pony or athlete is \$25 after the closing date. If the substitution is requested after the start of the competition, the show committee reserves the right to refuse.

**Refunds:**

After the close of entries, refunds of 50% of the class fees and 100% of other fees (except admin) will be awarded with veterinarian's or medical doctor's certificate. There are no refunds after the start of the competition.

**Drug Testing:**

Any horse entered in any class at a competition may be selected for equine medication control while at the event location. The testing fee for bronze competitions is \$4.00 per entry.

**Vaccination:**

All horses attending the competition will need to show proof of Equine Flu, Strangles and Rhino vaccinations for the current year, as well as a negative Coggins result. It is mandatory to attach photocopies with the entry form. If the horse is unable to receive one or any of these vaccines, please contact the show manager.

"All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations."

**Person Responsible:**

The Person Responsible (PR) for a horse must be an adult who has, or shares responsibility for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC Rules. The PR is liable under the penalty provisions of the applicable EC Rules for any rule violations. Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR.

The Person Responsible is ultimately responsible for the condition, fitness and management of the horse and is alone responsible for any act performed by himself/herself or by any other person with authorized access to the horse in the stables, elsewhere on the grounds, or while the horse is being ridden, driven or exercised.

**For Adult entries:** the PR shall be either the trainer, the owner of the horse of the competitor who rides or drives the horse during the EC sanctioned competition.

**For Junior entries:** they cannot be the PR. The PR in this case may be either the trainer, the owner of the horse, or a parent/guardian of the Junior competitor.

Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horses shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition.

**Memberships:**

All Bronze level competitors and owners are required to have the following memberships: PTSO (NBEA), Equestrian Canada Bronze Sport License or higher, and Horse Trials New Brunswick.

The Person Responsible must hold a valid Equestrian Canada Sport License at the same level or higher in which the horse is competing and a PTSO membership.

However, if the competitor is a Junior, the PR must be an EC Sport License holder in good standing OR a parent/guardian is entitled to sign as PR.

\*\*\*Proof of Memberships for the Rider, Owner and Person Responsible must be included with the entry form to avoid an incomplete entry charge. Please photocopy or email as attachments.

**SCHEDULE**

**Start** – after the completion of the bronze dressage show.

Dressage phases will be completed by all divisions (Starter through to Training), followed by the jumping phases in the same order.

Please ensure you provide a current email on your entry form to receive ride times. These will be emailed to riders **2 days prior** to the show.

It is hereby recognized that all equestrian sports involve inherent risk and that no helmet or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless EC, the competition, their officials, organizers, agents, employees and their representatives. The person responsible (PR) agrees to the release of any information on the entry form to EC. (A802.4)

Every entry at a recognized competition shall constitute an agreement and affirmation that all participants (which include, without limitations, the owner, lessee, trainer, manager, agent, coach, driver, handler and the horse), for themselves, their principals, representatives, employees and agents: (1) shall be subject and bound by the rules of Equestrian Canada and the local rules of the competition; (2) represent that every horse, rider, driver and handler is eligible as entered; (3) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and accept that no helmet or protective equipment can protect against all foreseeable injury, and by participation they expressly assume any and all risks of injury or loss to both horse or rider.

In consideration of being allowed to participate in this event, I hereby assume all risk and I hereby release and absolve the Organizing Committee of the Geary Hill Equestrian Challenge Show Series, National, Provincial and Discipline Affiliates, Equestrian Canada, the New Brunswick Equestrian Association and their Officials, Volunteers, Directors, Agents, Representatives and Employees and the Owners and Occupiers of the land upon which the competition is held from all responsibility, liability or claims of any nature and kind including communicable disease which arise from the participation in this activity, including the negligence of one or more of the individuals and organizations referred to herein. I hereby declare that in making this entry that I have read and fully understand and agree to the terms and conditions stated herein and that it is binding upon my executors, heirs and assigns.
