I acknowledge that the Equestrian Sport and its competitions are a high-risk sport and that I am participating at my own risk and in full knowledge of the hazards and potential hazards which are inherent in this sport. I further acknowledge the inherent risks in riding and working around horses, which risks include bodily injury to both horse and rider which can result from normal use, competition or schooling. In consideration of being allowed to participate in this event, I hereby assume all risk and I hereby release and absolve the Organizing Committee of the Carmaz Jumper Showcase, National, Provincial and Discipline Affiliates, Equestrian Canada, the New Brunswick Equestrian Association and their Officials, Volunteers, Directors, Agents, Representatives and Employees and the Owners and Occupiers of the land upon which the competition is held from all responsibility, liability or claims of any nature and kind which I may have arising from the participation in this activity, including the negligence of one or more of the individuals and organization referred to herein. Person Responsible agrees to the release of any information on the entry form to EC. "I hereby certify that every horse listed on this entry form has met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations."

It is recognized that all equestrian sports involve inherent risk and that no helmet, or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless, Carmaz Stables, this competition, their officials, organizers, employees and their representatives, from and against all claims including any injury or loss suffered during or in connection with the competition; anywhere on the grounds and surrounding area (ie: practice ring, stable area, visiting pastured horses) whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of Carmaz Stables or the Carmaz Stables Horse Show. It is understood that juniors who do not wear a properly fitted, ASTM or BSI approved helmet will not be allowed to compete at this show. Waiver must be signed by a parent or guardian if the competitor is a junior (18 years and under)
