Every class offered herein is covered by the current rules and specifications of EC and will be held and judged in accordance with the rules of the EC rule Book.



EQUESTRIAN CANADA STATEMENT OF PRINCIPLES

Statement of Principles - Horse Welfare 9.

EC supports adherence to humane treatment of horses in all activities under its jurisdiction.

- 10. EC is committed to:
- a) upholding the welfare of the horse, regardless of monetary value, as a primary consideration in all activities;
- b) requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to mistreatment;
- c) ensuring that owners, trainers, and exhibitors and their agents exercise appropriate care and responsibility in the handling, treatment, and transportation of their horses, as well as horses placed in their care for any purpose;
- d) providing for the continuous wellbeing of the horse by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety;
- e) continuing to support scientific studies on equine health and welfare;
- f) requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competitions; and,
- g) reviewing, revising, and developing competition rules and regulations that protect the welfare of the horse.
- 11. In determining whether conduct or treatment is cruel, abusive or inhumane, the standard to be applied will be the conduct or treatment expected of a reasonable person who is informed and experienced in equine training and exhibition procedures.
- 12. Individuals who interact with horses must also adhere to EC's policies as they relate to horse welfare.

EQUESTRIAN CANADA BELIEVES THAT:

- a) equestrian sport is based on a partnership between the horse and human athlete;
- b) it is the right and responsibility of EC to set standards in matters of ethics, sportsmanship and the welfare of the horse, and in all matters under its jurisdiction;
- c) it is desirable to define ethical practices, delineate unethical practices, and encourage good sportsmanship, fair play, and safety;
- d) all Individuals should observe the spirit as well as the letter of this Code; and,
- e) conduct contrary to this Code may result in the termination or suspension of membership and/or removal from participation in EC's activities or programs.



SHOW RULES

Administration:

- 1) All entry forms due no later than (5) days prior to the show as entries may need to be limited in some classes for safety and management purposes.
- 2) No entries accepted after July 3, 2023.
- 3) All information must be completed, and all forms signed and accompanied by payment for the entry to be accepted.
- 4) Payment may be made by e-transfer to: nkkbeau@hotmail.com or by cheques which must accompany entry form(s). Make all cheques payable to "Cadence Stables". No post-dated cheques accepted. NSF cheques will be charged \$50 administration fee.
- 5) Entry will not be accepted without payment. No entries will be accepted by telephone or fax.
- 6) Entry forms must be emailed in pdf to: Nicole Beaulieu at nkkbeau@hotmail.com or mailed to or dropped off at: Les Écuries de la Cadence Stables, 1280 Charters Settlement Road, NB E3C 1W3.
- 7) Copies of sport license, NBEA membership, negative coggins (within 2 years) and proof of vaccinations (Flu, Rhino, Tetanus and Strangles) must accompany entry form. (A602) All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations: see Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations.
- 8) All entries must be made in writing (Article A801.4) and paid in full. The show numbers will not be issued if all the required signatures are not complete.
- 10) Administration Fee and drug fee will be charged: \$35 for administration and \$4.00 for Bronze Drug Fee) (A602.5) and \$7.00 for Gold Drug Fee. Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location.
- 11) Hunter Classes are paid by division only whether you enter one or all classes.
- 12) Jumper Classes are paid for on a class basis.
- 13) Post entries will not be accepted.

- 14) Scratches will not be reimbursed.
- 15) Official protests must be made in writing and addressed to the secretary of the OC at the event which the matter under consideration occurs. Every protest must be signed and accompanied by a deposit of \$100 in cash. A protest is eligible only if made by an EC Sport License holder, Equestrian Canada Article A1204.
- 16) Ribbons 1st to 6th place. Championship prizes awarded to high point Horse/Rider combination accumulated at the show for Intro and Beginner Hunter, Jumper Divisions. Other championship prizes may be given if entries in other divisions are large enough. Tie breaker for Hunter G204.5, for Jumper G505.3
- 17) Competition number must be worn and visible at all times anywhere out of the stables at the event location, whether the horse is being hand walked or ridden. Section G Annex 1.2 page 99.
- 18) No pony shall be shown in any performance class where height is a restriction A1102 they must have the information recorded in the Horse Recording or a temporary measurement card available prior to the start of the class or the entry will not be allowed to compete. See G111 Pony Measurement. All foreign ponies must have an EC pony measurement card.

ARTICLE G111 PONY MEASUREMENT 4. Ponies eight years and over that have been officially measured in this process will be issued an official measurement card. 5. Ponies under eight years of age must be measured annually and will be issued a temporary measurement form. Show Committee reserves the right to measure any pony or horse entered in the show. If you have a pony which requires a measurement contact the competition prior to the event

- 19) If less than four entries are received for any class, the show committee reserves the right to cancel or combine classes.
- 20) Entry forms must be signed by competitor, owner and person responsible (Article A801). If the owner or exhibitor is under 19 years of age, the entry must be signed by a parent or legal guardian who assumes all responsibility and risk as stated on the form and by these rules and regulations. Parents and guardians are entitled to sign their children's entry forms without being EC members or holders of a Sport License. The entry form for all sanctioned competitions shall also be signed by the person responsible for the care, training, custody and performance of the horse.

The person responsible may be the trainer, owner, rider, agent or coach. The parent or guardian must sign the entry form for the minor/owner if there is no other person responsible. The person responsible is to be present at the competition and if they cannot attend, must appoint a representative who is present on the show grounds and must notify the competition secretary. Such substitute Person Responsible shall place his or her name on the entry form forthwith and thereby shall assume full responsibility for the performance of the duties. Article A1011.

The person responsible who signs an entry form must hold an EC or USEF individual license. For adult entries into EC sanctioned competitions the PR shall be either the trainer, the owner of the horse or the competitor who rides or drives the horse during the EC sanctioned competition. When the competitor is a Junior/minor owner, the competitor cannot be the Person Responsible and the

Person Responsible may be a parent/guardian. Parents/guardians are not required to have an EC Sport License or EC Registered Participant status provided they agree to abide by the rules and penalties in the Rule Book and acknowledge that they are liable under the penalty provisions of the Rules for any violations of the EC rules by their minor child (A 213.2). Foreign entries must sign an affidavit (Article A213.2).

- 21) Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horses shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. (A602.7)
- 22) Management has the right to expel any rider, owner or spectator deemed to be in their sole discretion disruptive to the show at any time.
- 23) Dogs must be leashed or caged while on the show grounds. The Owners are solely and expressly responsible for their dogs and the dog's behavior. Owners of loose dogs will be charged \$75.00 to retrieve their pets.
- 24) Absolutely "NO" smoking permitted on show grounds.
- 25) The show office will open one (1) hour prior to the start of the show and close 1/2 hour at the end of the show.
- 26) Bronze classes do not require Horse Recording. Bronze Sport licenses are required for all Bronze classes and can be purchased at www.equestrian.ca. Article A 207.
- 27) Gold Classes Gold EC Sport License requires and Canadian entries are required to hold an EC Horse Recording and have paid the EC Horse Recording annual Activation Fee to compete, or if owned by a temporary sport licence holder, a Temporary Horse Registration form must be purchased at each competition entered. Foreign entries must sign an affidavit. (See A404.2).
- 28) No fee for substitution of a horse (A603).



Services Offered

- A limited number of Box Stalls are available at a cost of \$30.00 per stall per day, shavings are for sale \$5.00 per wheelbarrow. Stalls are to be cleaned out at the end of the show. First priority will be given to exhibitors traveling from outside the Fredericton area.
- Hay is available at \$10.00 per bale.
- Warm up area will be available on the show grounds one hour before the competition on the day of competition. No horses may warm-up over fences in the competition arena regardless if the arena is unlocked or unattended.
- Cadence Stables main ring is 230' x 130'.

Directions:

To get to Les Écuries de la Cadence Stables take the Exit 285A at New Maryland continue on Hwy 101 through New Maryland and keep to the right from Hwy 101 onto Charters Settlement Road (there will be a fork in the road) Drive to the end of the road (approx. 6km). The stables are on the right-hand side.



Exhibitor and Owner Requirements

- 1) Equestrian Canada Bronze Sport License and NBEA membership are required to compete in Bronze classes. Equestrian Canada Gold Sport License and NBEA membership are required to compete in Gold classes. Riders from the USA must have the equivalent USEF membership or otherwise purchase a temporary Sport Licence. Equestrian Canada Bronze License is NOT required for exhibitors competing only in Lead Line. Lead line riders and adult leader must have a provincial membership. See class description for Leadline.
- 2) Bronze and Gold memberships may be purchased online at www.equestriancanada.ca. Your receipt will be proof of memberships. Temporary one-day memberships are no longer available for bronze".
- 3) Any horse entered in any class at a competition, may be selected for equine medication control testing while at the event location. (Article A602.5)
- 4) COGGINS TEST must be shown at office when picking up ring numbers. Coggins tests with a stamped date within two years of competition date will be accepted.
- 5) Horses must show proof of annual vaccinations for rabies, tetanus, Equine Influenza and Equine Herpes Virus and strangles. This includes any horse (non-competing) brought onto the property. All horses attending Equestrian Canada sanctioned competitions must have met the requirement of

Article A602.8 Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article 519, Vaccinations.

6) All horses attending Equestrian Canada sanctioned competitions must have met the requirement of Article A602.8 Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article 519, Vaccinations.

ARTICLE A519 VACCINATIONS

All horses attending Equestrian Canada sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave event site at the discretion of Competition Management. The frequency of vaccine administration should be as recommended by the vaccine manufacturer or veterinarian. It is recommended that vaccines be administered by or under the direction of a veterinarian. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements. In the case of a horse that is unable to receive either of the vaccines, a letter from a veterinarian on official letterhead must be provided with the entry form, stating the horse cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested.

- 6) Non-showing horses: All horses brought on the property during the competition must have a signed entry blank and owners must have a current NBEA membership. Anyone riding non-competing horses which have been brought on to the show grounds must wear a number issued by the office and have a current NBEA membership. Non-showing horses must meet coggins and vaccination requirements.
- 7) Amateur Owners must have current credentials (Article G108). An eligible temporary sport license holder may compete in amateur classes provided an Amateur Affidavit has been completed and is on file with the competition secretary (A208.4). A photocopy of the current amateur card must be attached with entry A802 .5 e).
- 8) As per Equestrian Canada rule article A805, the Show Committee reserves the right to refuse any entry, except as provided in 805.2 (a, b, c, d, e). The competition may refuse any entry failing to comply with the Prize List regulations or any competitor or owner who is determined to have failed to adhere to the standard of sportsmanship behaviour outlined in the Code of Conduct (A805.3).
- 9) The show will forfeit 75% of the entry fee less the fees for classes completed if the horse entered is withdrawn due to unsoundness or sickness provided a veterinarian's certificate is produced, dated no later than the closing day of the show and received within 10 days of the show date.
- 10) All riders, grooms, attendants and handlers must be neatly dressed on entering the ring. ARTICLE G109 DRESS. Dress code for jumpers G109 polo shirts neatly tucked into breeches are acceptable attire in the jumper ring.
- 11) When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self coached. Coaches from other countries, must

be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments.



SAFETY RULES:

1) ARTICLE G102 HEADGEAR

- a. At all EC-sanctioned competitions, anyone mounted on a horse on the competition grounds, including foreign competitors in EC National classes, must wear approved headgear, (see Glossary in General Regulations, Book A), with safety harness correctly fastened, at all times while mounted on the competition grounds.
- b. Juniors showing any horse in a jog for soundness must wear approved protective headwear with the attached safety harness fastened.
- c. Failure to comply with G102.1 or G102.2 in the exercise area and/or the competition arena will result in the following penalties:
 - i. 1st violation at competition: warning.
 - ii. 2nd violation at same competition: disqualification from the competition and forfeiture of all fees and prize monies.
- d. EC makes no representation or warranty expressed or implied about any protective headgear and cautions riders that serious injury or death may result despite wearing such headgear as all equestrian sports involve inherent dangerous risk and adds no protective headgear can protect against all foreseeable injuries.
- e. All violations which occur outside the competition arena will be reported to the judge/jury who will levy the applicable penalty.
- f. All violations which occur in the competition arena will be acted upon by the judge(s) who will levy the applicable penalty.
- g. For all competitors, if the harness comes undone or the hat falls off, the rider must retrieve and/or do up the hat, with assistance if necessary, before the next obstacle is taken. There will be no penalty other than the loss of time. Failure to do up the harness or retrieve protective headgear immediately results in elimination.
- 2) The show committee and facility owners do not accept responsibility for accidents or illness to horses, riders, grooms, spectators or any other persons.
- 3) ARTICLE G101 EMERGENCY MEDICAL SERVICES

It is mandatory that all EC – sanctioned Platinum, Gold, Silver and Bronze competitions have on site emergency medical services with a minimum of advanced first aid and basic cardiac life support (BCLS). Jumping in competition and warm-up areas should be suspended if the sole medic onsite is handling an emergency she/he cannot leave.

4) ARTICLE G103 FALLS

- 1. After being eliminated for a fall, the rider may not remount in the ring. Any rider who does remount in the ring after a fall will be eliminated from all classes in that ring for the remainder of the day. A rider who remounts after a fall and takes another obstacle will be disqualified from the remainder of the competition.
- 2. In the case of a fall of a horse or pony, Article A517.4 will apply. The officiating steward, judge, technical delegate, president of the ground jury or appointed competition veterinarian has the authority to remove a horse from the event for a period of up to 24 hours, if in their reasonable opinion the horse is unfit to compete, or where, in their reasonable opinion, there is a safety concern regarding the horse. The official's decision is final and cannot be appealed.
- 3. In the case of a fall of an Athlete anywhere within the grounds of the event during the hours of competition operation, the Athlete must be checked by the Competition's medical service, before the Athlete may continue to compete in the next round or Competition.

The competitor is solely responsible for ensuring the onsite medical assessment takes place. This rule is applicable to all competitors (including foreign) at EC sanctioned events and applies to falls/accidents that occur at the event location.

4) ARTICLE G104 IN-GATE

In all classes, trotting or cantering through the in-gate without prior permission is forbidden. The penalty for contravening this rule is either a fine or elimination from the class, at the discretion of the judge. Under special circumstances, a steward or judge may give permission for a horse to trot into the ring, but not out of the ring.

5) ARTICLE G105 STALLIONS

- 1. Junior B and C riders must not ride or handle stallions anywhere on the competition grounds. Jr. A riders may ride manageable stallions in jumper classes only. A stallion ridden by a Junior must be accompanied at all times by a competent adult/handler
- Person Responsible.' and Stallions may not be ridden in Pony Jumpers and Juniors may not ride stallions in any equitation class.
- 2. Manageable stallions ridden by seniors are eligible for all senior classes.

6) ARTICLE A808 and G501 HORS CONCOURS

- 1. "Hors Concours" entries may be accepted at the competition committee's discretion but are subject to the same scoring rules as a regular entry with respect to falls, elimination etc. Such entries are not judged and are not eligible for the jump off.
- 2. A horse or pony that has competed "Hors Concours" is not allowed to compete subsequently in the same ring on the same day.
- 3. "Hors Concours" entries will follow the last regular entry in the class.

- 4. "Hors Concours" is not allowed in the EC Hunter Division. G201.3
- 7. Cell phones, IPODS, etc. are not recommended to be used while riding. See ARTICLE G114 Earphones/earbuds and/or other electronic communication devices are strictly prohibited in the competition arena, and as such is penalized by elimination.) The use of only one earphone/earbud is allowed while mounted everywhere within the grounds of the Event except the competition arena.
- 8. Any horse that becomes out of control shall be eliminated from the competition at the discretion of the judge and Stewart .
- 9) Lunging will not be permitted in the warm-up ring if there are any riders in the warmup ring.
- 10) Schooling Rules: reference Hunter/Jumper schooling rules see Annex 1 page 99 Section G rule book. FEI Schooling Rules will be in place.



BRONZE HORSE SHOW

New Brunswick riders must have a NBEA membership. Bronze Competition Sport License must be purchased from Equestrian Canada – printed receipt will be accepted as proof of membership.

Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rules.

Horses entering Intro Hunter, Pre-Beginner Hunter, Beginner Hunter and Heritage Low Hunter at Bronze sanctioned competitions may only enter 2 of 3 divisions (Example: Intro and Pre-Beginner Hunter, or Pre-Beginner and Beginner, or Beginner and Heritage Low Hunter). The Cadence Classic may be entered in addition to the two divisions.

Open to Junior and Senior riders. Juniors of any age may show any height pony in these classes. A pony shown by an adult in these classes may not be shown by a Junior at the same competition. Adults may only ride large ponies (G306.2 &3).

In order for under saddle classes to count for awards, a horse must show and complete at least one over-fences class in the corresponding division (G318.1).

HUNTER DIVISION

Conduct of Hunter classes G401

Miscellaneous, not rated for Equestrian Canada Awards. Eligible for NBEA Year End Awards.

Entry Fee: \$60 per division (2 over fences + 1 under saddle)

Intro Hunter:

Over fences:

A simple hunter course of at least 8 fences with no combinations. Emphasis of judging on manners, obedience and style. Trotting to fences will not be penalized. Distances will not be adjusted for horses and ponies. Maximum height and width of fences to be 22" (0.55m). Fences may be low verticals or cross rails. The majority of fences will be 18" (0.45m). Open to seniors riding horses or large ponies and juniors riding horses or ponies or any height.

Under Saddle:

To be shown at walk, trot and canter, both ways of the ring. No more than eight horses will be asked to hand-gallop at one time.

- 1)Intro Hunter #1
- 2) Intro Hunter #2
- 3) Intro Hunter Under Saddle

Pre-Beginner Hunter: not to exceed (2'3") 0.70m

Over fences:

To complete a hunter-type jumping course of at least 8 obstacles not to exceed 2'3" (0.70m) in height. To be judged on obedience, jumping form and general way of going. The class is open to seniors riding horses or large ponies and juniors riding horses or ponies. The course may, but is not required, to be adjusted in height and distance for ponies. Juniors of any age may show any height of pony in miscellaneous, non-point classes.

Under Saddle:

To be shown at walk, trot and canter, both ways of the ring. No more than eight horses will be asked to hand-gallop at one time.

- 4) Pre-Beginner Hunter #1
- 5) Pre-Beginner Hunter #2
- 6) Pre-Beginner Hunter Under Saddle

Beginner Hunter: not to exceed (2'6") 0.75m

Over fences:

To complete a hunter-type jumping course of at least 8 obstacles not to exceed 2'6" (0.75m) in height. To be judged on obedience, jumping form and general way of going. The class is open to seniors riding horses or large ponies and juniors riding horses or ponies. The course may, but is not required, to be adjusted in height and distance for ponies. Juniors of any age may show any height of pony in miscellaneous, non-point classes.

Under Saddle:

To be shown at walk, trot and canter, both ways of the ring. No more than eight horses will be asked to hand-gallop at one time.

- 7) Beginner Hunter # 1
- 8) Beginner Hunter #2
- 9) Beginner Hunter Under Saddle

Cadence Classic: Max height (2'6") 0.75m. Not eligible for NBEA Year End Awards.

(Miscellaneous – not rated for EC awards) Entry Fee 40\$ Shown at a canter over 8-12 fences for first round and a shortened course for those who qualify for round 2. May include combinations, broken lines and roll backs. Max height 2'6". Top 6 from round one to return in order of 6th position up to 1st with both rounds receiving scores. Top score from both rounds will be the winner.

10) Cadence Classic

Heritage Low Hunter: (2.9) 0.85m

Miscellaneous, not rated for Equestrian Canada Awards.

Open only to horses or large ponies ridden by a Junior or Senior rider. Horses judged on obedience, jumping form and general way of going. Distances will not be adjusted.

Over fences:

To complete a hunter-type jumping course of at least 8 obstacles not to exceed 2'9" (0.85m) in height. Miscellaneous, not rated for Equestrian Canada Awards.

Under Saddle:

To be shown at walk, trot and canter, both ways of the ring. No more than eight horses will be asked to hand-gallop at one time.

- 11) Heritage Low Hunter # 1
- 12) Heritage Low Hunter #2
- 13) Heritage Low Hunter Under Saddle

JUMPER DIVISION:

Equestrian Canada rules G701-708, FEI Article 201-277

Local classes open to competitors from Atlantic Canada) Miscellaneous Not Rated for Equestrian Canada Awards. Eligible for NBEA Year End Awards.

MISCELLANEOUS JUMPER DIVISION: (Not Rated for Equestrian Canada awards) A503 Eligible for NBEA Year End Awards. See Equestrian Canada jumper rules. Junior, amateur or non-pro riders may not compete in draw reins or German martingales. G, Annex 1, page 100. 4.2. A horse/rider combination is permitted unlimited upward movement through divisions, but downward movement is restricted to only one level. These movements are based on the level of the first class in which they competed. G603 Welcome Article FEI 236 - 238.2Gamblers Choice Article FEI 270

0.70 (2'3") Meter Jumper – Immediate Jump -Off – Miscellaneous Not Rated for Equestrian Canada Awards. (No Prize Money) Eligible for NBEA Year End Awards.

Entry Fee: \$20 per class (not division)

0.75 (2'6") Meter Jumper – Immediate Jump -Off – Miscellaneous Not Rated for Equestrian Canada Awards. (No Prize Money) Eligible for NBEA Year End Awards.

16) .75 m Jumper Welcome

Gold Classes - Gold EC Sport License required and Canadian entries are required to hold an EC Horse Recording and have paid the EC Horse Recording annual Activation Fee to compete, or if owned by a temporary sport licence holder, a Temporary Horse Registration form must be purchased at each competition entered. Foreign entries must sign an affidavit. (See A404).
