






## Funding For Riders Who Are New to Sanctioned Competition

As part of this year's LTED program, the NBEA will be funding up to **fifteen new riders** to attend their first sanctioned shows in 2023.

-  5 hunter/jumper competitors
-  5 dressage competitors
-  5 eventing competitors

### HOW TO:

#### For hunter/jumper and eventing:

1. Submit your application to us and get approved.
2. Enter the show and send a copy of your entry to us.
3. We'll contact the competition and notify them that we'll be footing the bill.
4. Attend the show and have fun!
5. Once the show is over, we'll confirm your participation and pay the competition organizers.

#### For DNB dressage shows:

1. Submit your application to us and get approved.
2. Enter the show and pay the fees through the DNB online platform.
3. Once the show is over, we'll confirm your participation and reimburse your cost to you.

### IMPORTANT

- Riders will be funded on a first registered/first competed basis. Submit your application in plenty of time to learn if you are approved for this funding.
- Riders must be NBEA members
- Riders must have no record of having competed in any sanctioned competition before.
- All fees payable with the competition entry will be covered – class or division fees, drug & admin fees, levies, and stabling. (Coaching will not be covered).
- *Only the EC-sanctioned competitions listed on the NBEA are eligible* for funded entries. Thank you to those organizers for working with the NBEA to make this program possible! Non- sanctioned competitions of any kind are not eligible – see graphic below.
- Cancellation fees charged by competitions for entered riders withdrawing from the show will not be covered by the NBEA.

### Perks!

- **The NBEA Championships offers free entries to anyone who has competed at one sanctioned show during the year. This program will qualify 15 riders to attend!**
- **Attending two sanctioned competitions qualifies riders to earn year-end awards and prizes!**
