Membership in your Provincial Equine Association enables you to apply for low cost broad coverage insurance for any officiating and course design.

Acera Insurance is the official insurance broker of most Equine Associations in Canada.

### **Liability Insurance for Officials and Course Designers**

- Some competition organizers may not automatically provide protection for people providing service / hired for their events. This product ensures coverage is in place to protect you in your capacity as an official.
- ➤ The Insurance Program provides \$5,000,000. Commercial General Liability. The insurance provides coverage for "Provincially approved" and E.C. certified Officials who are officiating at events held by others. This means you do not have to worry about the insurance carried by event hosts.
- The coverage extends world-wide for officiating in jurisdictions where E.C. rules and regulations apply as a minimum standard and also covers course design.
- > The cost of this insurance coverage is \$350 and is contingent on the attached form being completed and returned to Acera Insurance for "approval". This must be done prior to being covered.
- Coverage Enhancement: Coverage automatically includes Professional Liability (Claims Made) with a \$100,000 limit per claim / \$100,000 annual aggregate

**NOTE:** Remember to enclose your payment as coverage cannot be made effective until we have received the application form and the premium payment.
