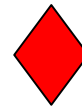

### Show Rules and Regulations

#### **Entries:**

All Entries must be sent to **21 Gallagher Road Lakeside NB E5N 7K2** and received **no later than June 18, 2014**. The show committee reserves the right to refuse any entry. **Faxes and Emails accepted.**

#### **Late Entries:**

Entries accepted after the closing date of **June 18, 2014** will be subjected to a late fee of \$30.00.

#### **Incomplete Entries:**

Any entries that **does not include:** photocopies of 2014 equine flu/rhino and strangles vaccinations and negative coggins within a 24 month period to the show date, photocopies of 2014 NBEA membership for the competitor and owner, completed entry form and signed waiver, will be subjected to an incomplete entry fee of \$30.00.

#### **Memberships:**

All competitors and owners require a 2014 NBEA membership.

#### **Vaccinations:**

All horses attending the competition require a 2014 equine flu/rhino and strangles vaccinations and negative coggins within a 24 month period to the show date.

#### **Refunds:**

After closing date, refunds of 50% of entry fees (not including administration fee) will be awarded with veterinarian's certificate. There are no refunds after the start of the competition.

**Ring Size:**

All tests will be ridden in a 20m x 40m sand ring.

**Ring Numbers:**

It is compulsory for the horse's competition number to be worn by the horse anywhere outside the stall from the time that the number is issued until the end of the competition so that officials can identify the horse.

**Tests and Divisions:**

The following dressage classes will be offered: Equine Canada Walk/Trot to Training Level and will be divided into Open, Amateur and Junior categories.

**“Every class offered herein is governed by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book.” Any situation requiring a ruling which cannot be referenced according to the Equine Canada and NBEA rules will be rendered by the Show Committee.**

**Awards/Ribbons:**

Ribbons for all classes will be awarded from 1<sup>st</sup> to 6<sup>th</sup> place. The award presentation will take place 10 minutes after the last ride of the day. **All competitors are required to be in full riding attire for this presentation.**

**Ride Times:**

The ride times will be available on Thursday Jun 26<sup>th</sup> after 5 pm and will be posted to Foshay South Eventing website [www.foshaysoutheventing.ca](http://www.foshaysoutheventing.ca) .

**Stabling:**

Limited stabling is available at a fee of \$40 per stall. Initial bedding provided.
